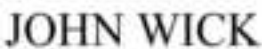

NOTICE OF OPPOSITION

Opposer Summit Entertainment, LLC (“Summit”), a wholly owned subsidiary of Lions Gate Entertainment Inc. (“Lionsgate”), and limited liability company organized under the laws of Delaware with a principal place of business at 2700 Colorado Avenue, Santa Monica, California 90404, believes that it will be damaged by the issuance of a registration for the trademark shown below (“Applicant’s Mark”) as identified in intent-to-use Application Serial No. 98/421,465 (the “Application”) in International Classes 13, 18, and 25, owned by Jane Wick LLC (“Applicant”).

As grounds for this opposition, Summit alleges as follows, with knowledge concerning its own acts, and on information and belief as to all other matters.

FACTUAL BACKGROUND REGARDING SUMMIT'S JOHN WICK MARK

1. Summit is currently, and for years has been, one of the world's leading entertainment companies engaged in the business of film financing, development, production and distribution, which has produced and/or distributed several award-winning movies, including the Academy Award[®]-winning film *La La Land* (2016), as well as the world-famous *The Twilight Saga* film franchise.

2. Among Summit's most successful films is the JOHN WICK franchise, which is distributed worldwide, including in the United States. The JOHN WICK franchise, including the films starring Keanu Reeves, began in 2014 with the release of the first motion picture, *John Wick*. This was followed by *John Wick: Chapter 2*, in 2017. The third film *John Wick: Chapter 3 - Parabellum* was released in 2019, and the fourth film *John Wick: Chapter 4* was released in the United States in March 2023. The highly anticipated spin-off film of the JOHN WICK franchise, *From the World of John Wick: Ballerina*, is currently set to release in June of this year, and Lionsgate has announced the development of an untitled spin-off film following the events of *John Wick: Chapter 4* based around Donnie Yen's Caine assassin character. In addition to numerous films, the JOHN WICK franchise also includes the television series *The Continental: From the World of John Wick*, as well as the recently announced television series titled *John Wick: Under The High Table*.

3. In addition to being widely acclaimed by critics, the JOHN WICK franchise has achieved significant financial success. In total, the JOHN WICK movies have grossed over \$1 billion in box office sales worldwide, achieving international fame and tremendous public recognition. The first JOHN WICK film grossed over \$43 million in the United States alone and over \$86 million in box office sales worldwide. *John Wick: Chapter 2* grossed over \$92 million in the United States and over \$174 million in box office sales worldwide. The third JOHN WICK film grossed over \$171 million in the United States and over \$328 million in box office sales worldwide. The most recent installment in the franchise, *John Wick: Chapter 4* grossed over \$187 million in the United States and over \$440 million in box office sales worldwide. This data has been obtained from Box Office Mojo and is attached collectively as **Exhibit 1**.

4. The JOHN WICK films have been nominated for and won many awards for their worldwide success. 5. Summit has extensively and continuously used and promoted the JOHN WICK mark (the “JOHN WICK Mark”) in connection with a variety of entertainment production, distribution, marketing, merchandising, and location-based entertainment-related goods and services.

6. In addition to the financing, development, production, and distribution of entertainment content, Summit is and has been for many years engaged in the business of using and licensing to others the right to use the titles, marks, and other elements of its audiovisual

entertainment programs in connection with a wide variety of products and services. This practice of licensing elements from a famous entertainment property is commonplace and well known to the general public and throughout the industry in general.

7. As a result of the success of the JOHN WICK franchise, and consistent with the practice of licensing elements from famous entertainment properties, Summit has for many years both used and licensed to others the right to use the JOHN WICK Mark in connection with a wide variety of products and services, including without limitation apparel, accessories, bags, collectibles, figurines, headwear, and home goods, a few examples of which are depicted on the following pages:

9. Reg. Nos. 5,104,817, 5,424,039, and 6,792,323 are valid and in full force and effect. Indeed, affidavits have been filed and accepted pursuant to Sections 8 and 15 of the Lanham Act for Reg. Nos. 5,104,817 and 5,424,039, rendering such registrations incontestable.

10. As a result of Summit's continuous and exclusive use of the JOHN WICK Mark in connection with its goods and services, the mark enjoys wide public acceptance and association with Summit and Lionsgate and has come to be recognized widely and favorably by the public as an indicator of the origin of Summit and Lionsgate's goods and services.

FACTUAL BACKGROUND REGARDING THE APPLICATION

11. Notwithstanding Summit's prior rights, and well after the JOHN WICK Mark became well known, Applicant filed the Application to register Applicant's Mark for use in connection with "Ammunition bags" in International Class 13, "Leather and imitation leather bags" in International Class 18, and "Athletic apparel, namely, shirts, pants, jackets, footwear, hats and caps, athletic uniforms" in International Class 25 (the "Applicant's Goods and Services").

12. The United States Patent and Trademark Office published the Application for opposition on October 22, 2024, and Summit timely filed an extension of time to oppose. Summit is now timely filing this Notice of Opposition.

13. There is no issue as to priority. The Application was filed on an intent to use basis on February 26, 2024. Summit began using the JOHN WICK mark in commerce in connection with entertainment services and related goods well prior to the filing date of the Application or any claimed date of first use of Applicant's Mark.

LIKELIHOOD OF CONFUSION

14. Summit incorporates the allegations in the foregoing paragraphs.

15. Applicant's Mark is confusingly similar to Summit's JOHN WICK Mark.

16. Applicant's Mark is likely to cause confusion, mistake, or deception as to the source, origin, affiliation, association, connection, or sponsorship of Applicant's goods offered under Applicant's Mark with Summit's JOHN WICK Mark.

17. Consumers familiar with the goods and services long associated with the JOHN WICK Mark are likely to assume that the goods and services offered under Applicant's Mark originate from the same source, or that they are affiliated, connected, or associated with or sponsored by Summit.

18. Applicant's Mark, as shown in the Application, incorporates the term WICK from Summit's JOHN WICK Mark along with the generic female name JANE (i.e., Jane Doe) in a manner that is confusingly similar to the JOHN WICK Mark in appearance and overall commercial impression. The incorporation of the term WICK with the name JANE, coupled with the fact that Applicant's Goods and Services cover goods which are associated with the JOHN WICK series (such as "ammunition bags"), is likely to leave the impression that Applicant is

associated with Summit as the female version of John Wick, the lead character in the JOHN WICK series.

19. Applicant's Goods and Services identified in the Application are identical and/or highly related to the goods and services Summit has long offered in connection with the JOHN WICK Mark, as demonstrated by the examples of JOHN WICK branded products in Section 7 above.

DAMAGE TO OPPOSER

20. Applicant's Mark differs from the JOHN WICK Mark by the word "Jane," which is not only generic, but also is a name that contains the same number of letters as "John." Applicant's Mark so closely resembles the previously used, and previously registered, JOHN WICK Mark that the use and registration of Applicant's Mark is likely to cause confusion, deception, or mistake as to the affiliation, connection, or association of Applicant with Summit, or the origin, sponsorship, or approval of Applicant's Goods and Services by Summit in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d), with consequent injury to Summit and the public. Further, any defect, objection, or fault found with Applicant's Goods and Services offered under Applicant's Marks necessarily would reflect on and seriously injure Summit's reputation.

21. Summit would be damaged by the registration of the mark shown in the Application, in that such registration would give Applicant a *prima facie* exclusive right to the use of JANE WICK, despite the likelihood of confusion described above.

PRAYER

WHEREFORE, Summit prays that this Opposition be sustained in favor of Summit, that the Application be rejected, and that registration of the Application be refused in its entirety.
